5.0 APA Iowa Membership Forum/Input

Mullenix opened the floor for membership input.

John Peterson presented on an opportunity with Active Living Iowa, started by the Iowa Department of Public Health. John presented to the board that he has the opportunity to lead the Active Living Iowa group with the concurrence of the Iowa APA Chapter Board. Those in attendance were supportive of John's efforts.

6.0 Business Items

6.1 <u>Chapter only membership for 2019 Iowa APA Conference non-member registrants.</u> Mullenix presented that in past years, non-APA members who registered for the APA-IA conference have been extended one-year APA-IA Chapter membership. 13 names from the APA-IA Conference in Iowa City were determined to not be members and proposed to receive a year of Chapter Only membership.

Motion made by Shires, seconded by Young. Unanimous Approval.

6.2 Approve 2020 Chapter Budget

Young reviewed the agenda as presented. He stated that the student scholarship amounts were low and were to be increased.

Motion to approve the 2020 board meeting dates and locations, made by Streams, seconded by Seabert. Unanimous Approval.

6.4 Approve 2020 Legislative Agenda

Van Steenhuyse presented a review of the 2019 legislative agenda.

- Tax Increment Financing (TIF) Reform
 - Recognizes that TIF is an important tool for local governments and supports the flexibility provided under current law.

• Water Quality and Conservation

 Supports funding and programs that facilitate and encourage nutrient reduction in Iowa's water bodies and improve Iowa's water quality. Furthermore, APA Iowa supports watershed-level planning that address urban and rural water quality, flood mitigation, and water recreation.

• Smart Planning Principles

o Supports comprehensive planning and the Smart Planning Principles outlined in Iowa Code and opposes any legislation to remove or weaken the practice of sound planning in Iowa's communities.

• Enhance Iowa Funding

o Supports programs that provide additional funding and/or incentives that encourage economic development. This includes support and additional funding for the newly created Enhance Iowa program and that program's Community Attraction and Tourism (CAT), River Enhancement Community Attraction and Tourism (RECAT), and Sports Tourism funds.

• Brownfield/Grayfield Redevelopment

o Supports efforts and funding to enhance the Brownfield and Grayfield Redevelopment program to encourage sustainable development and to revitalize blighted and distressed areas.

Minimum Wage

O Supports a statewide increase to the minimum wage to ensure equity in economic development efforts as well as to ensure income thresholds for social services are not disproportionate across the state.

Local Control of Planning Issues

o Believes local jurisdictions should have control on planning issues and opposes state legislation that mandates regulations or limits local planning and zoning powers. Examples issues include the regulation of adult oriented businesses, residential occupancy restrictions, firework legalization, and cellular tower/small cell placement.

Livable Communities

o Supports state policies that seek to improve quality of life by promoting development of safe, accessible, and vibrant environments. Policies could address sustainable land use, mixed use developments, multigenerational and affordable housing, alternative transportation, and efforts to help residents age in place.

Housing

Supports increased investment in affordable housing programs, including the State Housing Trust Fund, Workforce Housing Tax Credits, and other programs that support the modification of homes to help people age in place.

Van Steenhuyse recommends reconsidering the minimum wage priority now that the State legislature has mandated a state level wage.

Van Steenhuyse recommends including a priority on land banking. Board is supportive of including a new priority in the agenda for land banking policy.

Iowa Great Places and Climate Change are additional topics the board suggested. Van Steenhuyse will prepare policy statements for what was discussion for future board consideration.

No action was taken.

*Fleener joined the meeting at 10:28 am.

6.5 <u>All Iowa Reception at 2019 National Planning Conference Funding (Houston)</u> Mullenix presented to the board that the chapter historically contributes to an allIowa reception along with participation from Iowa State and University of Iowa. The 2020 National Planning Conference will be located in Houston, Texas.

Motion to approve funding by Young and seconded by Van Steenhuyse. Unanimous Approval.

7.0 Discussion Items

7.1 Review of 2019 Iowa-APA Conference (Iowa City)

Sturms presented a review of the state conference activities. Sturms mentioned that the venue did reduce the room rental and food costs due to issues with the venue. The board discussed feedback received in the post-conference survey.

In addition, Mullenix plans to do a review with the Iowa City local conference committee to evaluate the planning process and improvements. The conference committee will be working to compile the presentations from the conference to post to the chapter website.

Fleener presented that Mentor Match sessions at the conference went well.

7.2 2020 Upper Midwest Conference (Des Moines)

Mullenix reported that he will be reaching out to the National APA President to attend the 2020 conference. He also presented that agreements with the events center have been signed and that the local planning committee is being developed and will convene in January 2020 to begin organizing. Sturms reported to the board that Kristina, the Chapter Administrator, will be our key personnel to organize many aspects of the conference.

8.0 Officers Reports

8.1 President (Mullenix)

Mullenix reported Perkins has resigned as of the end of October 2019 and commended her great work over years. Mullenix also recognized Filippini for his term ending as Chapter Secretary at the end of the year.

Mullenix reported that he will have a chapter report available at the beginning of 2020.

Mullenix reminded the board to send him photos and bios for the website.

8.2 Vice President (Sturms)

Sturms reported she will be finalizing the contract with Ottumwa for the 2021 conference.

Sturms also reported that National APA has asked chapters about having a climate and sustainability liaison. Someone has been identified to serve in that role.

Champ gave a report on a program review session he participated in at University of Iowa.

Young reported that he has experienced issues with US Bank and was unable to provide a report. He reported that the Chapter has \$86,000 in the account. After paying bills, should expect to have \$42,000 balance. The chapter will be transferring the account to a bank in coordination with our new Chapter Administrator.

Wilwerding reported that the AICP testing window is open through Monday. Nine registered for the exam.

Russett reported that next Thursday will be the next Corridor happy hour at Joe's Place in Iowa City. Russett also reported that Iowa City has created a Climate Action Commission and ask if planners would be interested in volunteering assistance for the commission.

Janson reported that he plans to set up events for the next 6-months.

9.7 Professional Development (Shires)

Shires reported that he will work to organize the next board meeting in Ames in January.

9.8 Outreach / Advocacy Program (Schroder/Tiedemann)

Tiedemann reported that they will be engaging other organizations on activities that may be able to collaborate on in the fall during the conference.

Schroder reported that they are continuing to engage other organizations.

9.9 Legislative and Policy Program (Van Steenhuyse)

Van Steenhuyse reported that APA will be hosting a State Legislative Summer in Richmond, VA. in December. He also reported that the annual Design Professionals Day on the Hill will take place in January. He will be working with AIA for more information. He plans to find ways to have more planners engage with their law makers.

9.10 Recognition / Awards Program (Cowell/Bothell)

Bothell reported that they sent a press release with the 2019 award winners and that the award presentation is now available on the chapter website. The chairs also have photos of the event and are available if anyone is interested.

9.11 Public Relations / Communication Program (Seabert)

Seabert reported that Facebook activity is steady. She asked to continue to send her items to share. Next newsletter will be going out in early January.

9.12 <u>University of Iowa Graduate Program (Begay)</u>

Begay reported that students are taking advantage of the activities of the chapter. Begay also reported that the students are planning a road trip to Detroit, MI in March. Finally, requested that the Student Chapter information on the chapter website to be updated with student organization information.

9.13 <u>Iowa State University Undergraduate Program (Hertaus)</u>

Hertaus reported that students are involved in a number of plans around the State of Iowa such as the City of Ames comprehensive plan and the state bike plan. 


Membership by Type

CHAPTER DEVELOPMENT

Administrative Support

In September 2019 the APA lowa board agreed to retain paid administrative support for the first time. The board retained the services of firm Sickels & Associates, an Indianola based company who will approximately 10 hours of assistance per month. These services will include financial management services, meeting management and event coordination, and advisory services to help carry out APA lowa's policies.

2020 Work Plan

In November 2019 the APA lowa board held a strategic planning session, facilitated by Terry Berkbuegler with Confluence, to help refine the 2020 work plan. Board members reflected on the work accomplished throughout 2019 and identified new priorities for 2020. Among the priories for 2020 are increased engagement of students and young professional, hosting more professional development opportunities outside of central lowa, and expanding the profile and influence of the chapter.

New Website

Over the last few years APA national has assisted chapters and divisions transition to a new, free website platform. In 2019, APA lowa transitioned to this new platform, which was formally launched at the APA lowa Annual Conference in October. The new website is easier to manager, has better integration with the materials offered by APA national and with APA member accounts, and provides more functionality such as the ability for members and their employers to post jobs directly to the site. The new website can be found at iowa.planning.org. Special thanks to Seana Perkins for working with APA to transition the chapter's website to the new platform.

Chapter Elections

APA lowa held its biennial elections earlier in summer 2019 for board positions that will run from January 1, 2020 through December 31, 2021. Current office holder of President (Dylan Mullenix, Des Moines Area MPO), Vice President (Madeline Sturms, City of Pleasant Hill), and Treasurer (Zach Young, Des Moines Area MPO) were reelected for a second term. Bill Micheel, City of Cedar Rapids, was elected as the chapter's new Secretary and will replace Tony Filippini, Des Moines Area Regional Transit Authority, who chose not to run again. Past President Ben Champ, City of Pleasant Hill, will continue in that role to round out APA lowa's officers for 2020-2021.

PROFESSIONAL DEVELOPMENT

AICP Exam Results

In the May 2019 and November 2019 testing windows, 12 planners passed the AICP exam; 6 through the traditional process and 6 through the AICP Candidate program. Iowa's planners continue to excel when it comes to passing the AICP exam. In the May test, APA Iowa members taking the AICP exam had a 100% pass rate for the traditional process compared (national pass rate of 63%) and a 66% pass rate for the AICP Candidate program (national pass rate of 56%). In November, APA Iowa members had a 33% pass rate (national rate of 62%) for the traditional process and an 80% pass rate (national rate of 55%) for the AICP Candidate program.

CM Offerings

In 2019, APA lowa offered 74.75 hours of CM opportunities to members, compared with 63 hours offered in 2018. The majority of these (52.75 hours) were offered directly by APA lowa. Other were offered by partnerships with the University of Iowa (8 hours), the Iowa Section of the Urban Land Institute (6 hours), the Tomorrow Plan Speaker Series (4.5 hours), the Bi-State Regional Planning Commission (3 hours), and the Iowa Environmental Council (1.5 hours).

CM Partnership Policy

APA lowa is a registered CM Provider through the American Planning Association and provides this service so that AICP members have ability to receive CM credits throughout lowa, including APA lowa events and conferences. APA lowa frequently partners with other groups and organizations to co-sponsor training events so those events can qualify for CM credits. To partner with other groups to offer CM credits, APA lowa must follow the guidelines set forth in the CM Provider Toolkit. To help ensure these guidelines are followed, in 2019 APA lowa adopted a CM Credit Approval Policy to provide guidance for such situations.

APA National Conference

APA lowa had a strong turnout at the APA National Conference held in San Francisco. Sixty-five APA lowa members attended the conference, including sixteen students. APA lowa partnered with lowa State University and the University of lowa to hold the All lowa Reception, which was attended by approximately 50 people. Additionally, numerous student groups participated in the poster contest.



2019 APA Iowa Annual Conference

APA lowa held its annual chapter conference in lowa City from October 9-11th. Just over 250 attendees participated in the conference. 48 AICP CM credits were available at the conference. New APA CEO Joel Albizo was in attendance and was highly complementary of the chapter and the quality of the conference.

2020 Upper Midwest APA Conference



The Tomorrow Plan Speaker Series

The Tomorrow Plan Speaker Series hosts national thought-leaders who share ideas, insights, and inspiration with regional influencers to advance the sustainable development of Greater Des Moines. APA lowa joined the speaker series board in 2018. In this role, APA lowa has been able to get the free events approved for AICP CM credits.

Planning Healthy Iowa Communities

APA Iowa continues to be a proud supporter of Planning Healthy Iowa Communities, a collaborative effort led by APA Iowa and the Iowa Public Health Association with a grant from the APA Planners4Health initiative. Planning Healthy Iowa Communities works to bring together representatives from planning, public health, and environmental health to help identify ways these organizations can work to



encourage more physical activity, healthier food choices, a more thoughtful built environment, and an enhance natural environment.

APA lowa provides a scholarship through the Planning Healthy lowa Communities collaborative to help connect public health representatives to the planning community. In 2019, Kelli Gerdes, the Health Promotions Manger for Cerro Gordo County Public Health Department and a member of the lowa Public Health Association received this scholarship via an essay contest. The scholarship provided free registration and accommodations at the 2019 APA lowa Conference in lowa City.

LEGISLATIVE EFFORTS

State Advocacy

APA lowa annually develops a state legislative agenda and engages in the lowa legislative process when necessary. Periodic updates are made throughout the legislative session to APA lowa members about planning-related legislation making its way through the legislature. When necessary, APA lowa works to educate legislators on the potential planning-related impacts of pending legislation. APA lowa also participates in Design Day on the Hill along with partner organizations such as the American Institute of Architects, American Association of Landscape Architects, and the Green Building Council.

APA lowa's Legislative and Policy Chair, Steven Van Steenhuyse of Mason City, leads the chapters legislative efforts. In December 2019, Steven attended a State Legislative Summit, organized by APA, in Richmond, VA. The summit brought together legislative liaisons from 28 chapters to learn from each other about best practices in legislative advocacy and to learn more about legislative issues anticipated in 2020. Steven's travel was provided in part by a grant from APA national.

Federal Advocacy

APA lowa representatives also engage with peers on a national level regarding planning-related legislation. Each September, APA lowa's President as well as the Legislative and Policy Chair travel to Washington, D.C., to participate in APA's Policy and Advocacy Conference. This trip also allows APA lowa to engage lowa's congressional representatives about planning issues as part of an APA Planners Day on the Hill. In 2019, Steven Van Steenhuyse, APA lowa's Legislative and Policy Chair, met with several members of lowa's congressional delegation or their staffs to discuss national planning issues, such as affordable housing, and to apprise them of planning projects in lowa.
