# CHAPTER UPDATE FROM THE APA IA PRESIDENT

Happy New Year Iowa Planners!

Below are a few updates about the chapter's recent activities and items of interest.

The APA lowa board, at its January meeting, approved its 2021 work plan and budget. These documents are available on the APA IA website and outline what the chapter hopes to accomplish this year. Work on 2021 priorities kicked off with a strategic planning session in November, facilitated by Terry Berkbuegler with Confluence. Notable additions to the 2021 budget are providing board diversity/equity training, as recommended by the newly created Diversity, Equity, and Inclusion Subcommittee, and procuring lobbyist services. To help increase revenues, the chapter has introduced an annual sponsorship program. This will allow companies to sponsor the chapter beyond the annual conference, such as sponsoring professional development opportunities, webinars, social events, and newsletter content.

By January of each year the APA lowa Chapter must document its compliance with Chapter Performance Criteria set forth by APA. These criteria ensure that local chapters provide quality level of service to its members and communities. In addition to the budget and work plan, mandatory elements required are current bylaws, financial procedures, strategic planning documents, and an annual report.

We are again preparing for a year in which most chapter activities will be virtual, although we do hope to still be able to hold an inperson conference in October. While virtual events can be limiting in some respects, we have found that more planners from throughout the state are able to attend. We will continue to monitor the COVID-19 situation to gauge when might be appropriate to resume in-person events. Additionally, a survey to the APA IA membership will be released by the end of January that will include questions regarding the members' comfort level with potential in-person events.


# CROWDSOURCE REPORTING APPS – GIS FOR CITIZEN-DRIVEN PLANNING

Planning, developing, and maintaining community infrastructure works best when citizens are engaged in the process. Yet, gathering and synthesizing all of that input can be laborious. This is where GIS comes in. Crowdsource reporting apps help communities prepare for future growth and more accurately budget for necessary repairs, developments or upgrades by placing easy-to-use applications in the hands of the people.

#### Planning and Development

Implementation or updating of comprehensive plans, capital improvement plans or park plans requires public involvement, whose input is critical in building consensus, especially if a bond or other public funding is required. A crowdsource reporting app can be custom configured with an online interactive map for citizens to add comments, identify needs or offer ideas for development during the planning process. Participants can click on locations of their choice and add photos or thoughts about pedestrian routes, trails, development opportunities, parks, safety concerns, or to identify spaces they feel need preservation.




#### Public Works and City Services

Crowdsourcing apps are also invaluable for identifying public works or transportation needs and budgeting for repair or replacement. Here, citizens can identify where utilities might need maintenance, if a particular intersection poses safety concerns, which potholes need attention, where a sidewalk is in disrepair, or an intersection non-ADA compliant. This feedback is gathered in real time by city officials, who can then issue work orders to provide maintenance or track completion of the task.



#### CONTINUED: CROWDSOURCE REPORTING APPS



Crowdsource App Synthesis

Synthesizing data acquired through crowdsource apps is simple and intuitive, yielding at-a-glance data summaries, category engagements, comments, and a graphic map with pins and icons that identify where the public has expressed an opinion. From here, a GIS team can build output models such as heat maps that aggregate all input data into easy-to-digest summaries. Citizens can watch projects get checked off the list and recognize their feedback is making an impact.

For leaders and planning directors with plenty on their to-do lists, crowdsourcing apps are a cost-effective and efficient means to plan for and preserve all the amenities their residents hold dear, and to prove that communities truly are built by the people.

Who: Nonprofits, Communities

What: Designation, professional development and fall 2021 funding eligibility with an average award of \$227,355 with a required 1:1 match

When: Deadline to apply for designation is May 3, 2021. Applications will soon be available online. Interested applicants can access the FY2021 designation guidelines online.

#### **COMMUNITY CATALYST GRANT PROGRAM**

Through the Community Catalyst Building Remediation Program, the lowa Economic Development Authority provides grants to communities for the redevelopment, rehabilitation, or deconstruction of buildings to stimulate economic growth or reinvestment in the community. Strong applications will show the potential of catalytic economic growth in the community; improve appearances & safety; make use of underutilized property, exhibit appropriate design standards; and be well-funded. Economic growth may include the creation of additional jobs, growth of new or existing businesses, development of new housing units, increase property values, or potential population growth.
